

Notice of Race
Santana 23 National Championship Regatta
Johnson Lake Yacht Club, Lexington, Nebraska
July 8-9, 2006

Johnson Lake is a man made water storage reservoir in central Nebraska. With just over 3000 acres it is a wide open lake perfect for sailing in the great Nebraska winds. Water level is maintained at the full level throughout the summer. There are three boat ramps and the lake is deep enough for keel boats. Rules: The regatta will be governed by the current Racing Rules of Sailing, the prescriptions of the US Sailing Association, the Santana 23 Class Constitution and Bylaws, (except as any of these are altered by the Sailing Instructions) and by the Sailing Instructions. A copy of the Santana 23 constitution and bylaws will be sent to each S-23 skipper pre-registering. The Santana 23's will hold a National Class Assn meeting on July 8, 2006 to conduct the business of the class. The Johnson Lake Yacht Club recognizes the possible variations in Santana 23 sailboats and sails, and would like to allow some flexibility in measurements while still upholding the one-design nature of the class.

Regatta Headquarters: Lakeshore Marina on north side of Johnson Lake.

Schedule:

Friday July 7:

1600-1900 hrs. Sail measurement and possible boat inspection or measurement at Headquarters

Saturday July 8: Headquarters

0800 to 0830 hrs. Sail and boat measurement

0800 to 0830 hrs. Registration

0830 to 0900 hrs. Skippers meeting

1025 hrs. Warning signal for first race, subsequent races to follow

1800 hrs. Dinner and Santana 23 National Class Meeting

Sunday July 9:

0855 hrs. Warning signal for first race of day, subsequent races to follow.

Dinner and award presentations following races.

Fees: The Regatta fee is \$40.00 with a late fee of \$10.00 after July 1, 2006. Pre-registration is requested. Tickets for the Saturday evening dinner will be available for purchase at Registration. Lunches available at Marina and restaurants located on lake.

Trophies: Top four places will be awarded.

Sailing Instructions: The Sailing Instructions will be available at Registration.

Scoring: The Low Point Scoring System of Appendix A of the RRS will apply. Seven races are scheduled on July 8 and 9, of which one shall constitute a regatta. If seven races are sailed, one throw-out is allowed in the scoring.

Regatta Location: Johnson Lake on Hwy 283, 7 miles SW of Lexington NE, Interstate 80, exit 237.

Accommodations: Plentiful tent and trailer campsites are available at a State Park site on the lake. Limited slips and moorings are available for the boats. Modern cabins at two locations around the lake are available or a Holiday Inn Express and other motels located 7 miles away at Lexington, NE
